

# Fachtag zum Deutsch-Israelischen Jugendaustausch in Theorie & Praxis Aktuelle Entwicklungen – Bleibende Herausforderungen – Neue Materialien

#### 22. Juni 2017 in Berlin

Das große Jubiläum der Beziehungen zwischen Deutschland und Israel im Jahr 2015 hat neue und bleibende Anknüpfungspunkte für die deutsch-israelischen Jugendkontakte markiert. Einen davon haben das Bundesministerium für Familie, Senioren, Frauen und Jugend, ConAct und die Israel Youth Exchange Authority als Themenschwerpunkt aufgegriffen und in den Mittelpunkt gestellt: Das Leben in offenen und demokratischen Gesellschaften ist seit Jahrzehnten ein wichtiges Thema in deutsch-israelischen Bildungs- und Austauschprogrammen und bedarf gleichzeitig aktueller Akzentsetzungen.

Im Projekt "Living Diversity in Germany and Israel – Challenges and Perspectives for Education and Youth Exchange" arbeiten Fachkräfte und Träger seit mehr als einem Jahr gemeinsam daran. Inhalte und pädagogische Ansätze diversitätsbewusster Bildungsarbeit in Deutschland und Israel zusammenzutragen, zu diskutieren, neue Impulse für die Austauscharbeit zu entwickeln und neue Zielgruppen einzubeziehen. Das Projekt "Living Diversity", welches im Bundesprogramm "Demokratie leben!" 2015–2018 gefördert wird, dient dazu, ein deutsch-israelisches Netzwerk von Trägern und Fachkräften der außerschulischen Jugendarbeit aufzubauen, welche sich in ihrer Bildungs- und Austauscharbeit für ein gleichberechtigtes Miteinander in der Gesellschaft gegen Ausgrenzung und Diskriminierung einsetzen. Ziel des Projekts ist es, die Achtsamkeit für die bestehende Vielfalt – etwa an kulturellen, religiösen und sexuellen Orientierungen, an ethnischer und sozialer Zugehörigkeit und an körperlichen und geistigen Fähigkeiten – im Leben und Lernen junger Menschen in Deutschland und Israel zu erhöhen.

In der Mitte der Laufzeit dieses Themenschwerpunktes gilt es, das bisher Erreichte zu reflektieren: Welche Einsichten konnten Mitwirkende und Teilnehmende des Diskurses zu Diversität und Vielfalt in beiden Ländern bisher gewinnen? Welches sind zentrale Diskussionspunkte, gleiche und differierende Perspektiven? Welche Implikationen für die gemeinsame pädagogische Arbeit lassen sich ableiten? Was bleibt zu tun, um die angestrebten Ziele von Vernetzung, Qualifizierung und motiviertem Handeln für eine diversitätsbewusste und lebendige demokratische Bildungsarbeit zu erreichen?

# Current Developments – Remaining Challenges – New Materials June 22, 2017 in Berlin

The anniversary of the relations between Germany and Israel in the year 2015 marked both new and existing long-lasting linkages for German-Israeli youth contacts. The Federal Ministry for Family Affairs, Senior Citizens, Women and Youth, ConAct and the Israel Youth Exchange Authority have now put a focus on one of those key aspects: Life in open and democratic societies has been an important topic in German-Israeli education and exchange programs for decades and is at the same time in need for new actions and measures.

The project "Living Diversity in Germany and Israel", which is mainly funded by the German federal program "Live Democracy!" aims at developing a German-Israeli educational network of organizations and professionals who wish to actively deepen the consciousness of democratic values in youth work and exchange projects. The project aims to increase the awareness of the existing diversity – such as in cultural, religious and sexual orientation, ethnic and social belonging and physical and mental abilities – in both countries.

For more than a year, the project "Living Diversity in Germany and Israel – Challenges and Perspectives for Education and Youth Exchange" has been offering a platform to professionals and organizations to exchange and discuss on diversity-conscious educational approaches, reflect upon educational strategies, develop materials for youth exchange and expand their network including new target groups.

As part of a mid-term review of the project it is now important to reflect on the achieved results:

Which valuable insights could participants and contributors gain in the discourse on diversity and pluralism in both countries until now? Which are focal points of discussion and where can similar or differing perspectives be described? Which implications can be derived for common educational work? What remains to be done in order to achieve the goals of networking, qualification and motivated action for diversity-conscious and democratic educational work?

We cordially invite interested partners, team leaders and youth workers of German-Israeli exchange programs and non-formal education to take part in this professional forum for networking and exchanging ideas — right in the middle of the year 2017!

# **Contributors**

#### **Amram Aklum**

Amram Aklum is an educator and activist. He promotes the Ethiopian community in Israel and has been the director of *Ashalim* program in *JDC Israel (American Jewish Joint Distribution Committee)*. Ashalim is an organization which develops solutions and services for youth at risk populations, starting from birth to age 25, in order to ensure the welfare and well-being of children, youth, young adults, and families at risk. Amram Aklum is in charge of guiding and organizing the youth journeys to Ethiopia.

#### Ilira Aliai

Ilira Aliai is an educational coordinator in the project "Living Diversity in Germany and Israel". She was born in Albania and grew up in Greece. Ilira Aliai studied German language and literature in Athens and Berlin and has a Master's degree in cultural management. She is active in the field of political education and youth work with focus on identity and diversity issues in migration societies.

#### Miriam Awad Morad

Miriam Awad Morad is a representative of the Israeli Youth Movement *Noar Oved*, Israel. She is in charge of the Arab section of the movement, working with youth and young adults. Miriam Awad Morad is a member of the advisory council for the German-Israeli project "Living Diversity in Germany and Israel".

#### **Volker Beck**

Volker Beck is chairman of the German-Israeli Parliamentary Group of the German Bundestag since 2014. He was a member of the Alliance 90/The Greens party council from 2002 to 2013 and is a member of the German Bundestag since 1994. He was legal affairs spokesman for the ALLIANCE 90/THE GREENS parliamentary group from 1994 to 2002; political coordinator of the working

group on internal and legal affairs, women, youth and petitions within the parliamentary group's executive committee from 1998 to 2002; first Parliamentary Secretary of the Alliance 90/The Greens parliamentary group from 2002 to 2013.

#### Cirsten Behm

Cirsten Behm is a trained choreographer and dance pedagogue, working in the field of dancing with children and youth in the leisure segment since 1987. She founded the *Tanzwerkstatt No Limit e.V.* 17 years ago. She understands dancing as a meeting point, were children and young people can meet and get to know each other. In 1999 she received the badge of honor from the Berlin Senate; in 2012 she was awarded the Grand Cross of Merit of the Federal Republic Germany.

#### **Immanuel Benz**

Immanuel Benz is board member of the German Federal Youth Council. He is a member of the socialist youth movement *Die Falken* since 2007, and since 2013 head of the board. He studied Political Science, History and Journalism. The focus of his work besides socialist education is commitment for serious participation possibilities for children and youths as well as cooperation in the field of the International Falken-Movement.

# **Aycan Demirel**

Aycan Demirel is co-founder and board member of the organization *Kreuzberg Initiative Against Antisemitism*. He is currently leading the federal pilot project *Preventive Educational Processes for Islamism in School* and is a member of the *Independent Expert Panel on Anti-Semitism* that works on behalf of the German Federal Government.

#### Dr. Thomas Feist

Dr. Thomas Feist is a member of the German Parliament. From 1993 to 1995 he was an educator for children with learning difficulties and socially disadvantaged youth. Since 1995 he works as an advisor for youth education, music and intercultural work. He has studied Music Sciences, Sociology and Theology and holds a PhD title. Since 2007 he is a member of the Christian Democratic Union (CDU) of the local group in Neue Messe/Leipzig. He was a founding member of Beatzentrale e.V. and since 2010 he is the president of the German-Israeli Friendship Society in Leipzig. He is president of the regional committee in Leipzig for "Jugend musiziert" and also member of the Parliamentary Forum Middle and Eastern Europe e.V.

#### Ariella Gill

Ariella Gill was born 1963 and studied at the Technion Israel Institute of Technology, Haifa. Since 1995 she is project director of the Israel Youth Exchange Authority. The authority was established according to a government decision in recognition of the importance of exposing the young generation and the decision makers of the future to their peers around the world. The concept that guides the youth exchange is based on the assumption that becoming familiar with the mosaics of people and cultures around the world assists in structuring a foundation of common values, leading to mutual respect and better understanding. Ariella Gill is a member of the mixed commissions of bilateral work between the authorized representatives of the state of Israel and foreign countries in the field of youth exchange. Furthermore, she is supporting and guiding the Israeli organizations in implementing youth exchange projects.

#### **Kerstin Griese**

Kerstin Griese is the vice president of the German-Israeli Parliamentary Group since 2014. She did her M.A. in History and Political Science at the Heinrich Heine University in Düsseldorf. From 1987 to 2000 she was a free-lance staff member and research assistant at the Memorial Center for the Victims of National

Socialism in Düsseldorf. She released publications on persecution and resistance and psychiatry in Nazi Germany, German-Jewish history and educational commemoration in Memorial Centers. Since 1986 she is a member of the Social Democratic Party of Germany (SPD); Since 2000 she is a member of the German Parliament.

### Dr. Elke Gryglewski

Dr. Elke Gryglewski was born 1965 and is a political scientist. She did her doctoral dissertation on approaches of Berlin youths of Arab-Palestinian and Turkish backgrounds to the history of National Socialism and the Shoah. Since 1995 she is an academic pedagogical staff member at the *House of the Wannsee Conference Memorial and Educational Site*. She designs and organizes seminars on different topics in context of the history of the persecution and murder of the European Jews and the exposure to Nazi crimes after 1945. She regularly organizes German-Israeli exchange projects in the field of commemoration within a diverse society.

#### Jan Holze

Jan Holze is chairman of the German Sports Youth as a section of the German Olympic Sports Federation. Before that he was a board member of the Sports Youth in Mecklenburg-Vorpommern. He was head of the youth movement of the European Non-Governmental Sports Organisation (ENGSO) since 2010 and vice president of the ENGSO since 2015. Jan Holze is a lawyer and certified salesman and works as the managing director of the Foundation for Voluntary Engagement in Mecklenburg-Vorpommern.

#### **Prof. Doron Kiesel**

Prof. Dr. Doron Kiesel was born in Israel. At the age of 10 he moved to Germany with his family. After finishing high school he returned to Israel, served in the army and began to study at the University of Jerusalem. He continued to study educational and social sciences at the University of Frankfurt am Main. He is

professor for Cross-cultural Studies at the University of Applied Sciences in Erfurt, Germany. Since 2012 he is director of the Education Department of the Central Council of Jews in Germany. Prof. Kiesel has published numerous publications in the field of intercultural education in migration societies and about the Jewish community in Germany.

#### Falko Kliewe

After gaining some work experience in Israel, in a publishing house and as a facilitator in political youth exchange for the Network for Democracy and Courage he is now working as an educational coordinator for ConAct — Coordination Center German-Israeli Youth Exchange. Studying media and social science, he made his first contact with Israel in 2008 and was confronted by a range of issues, friends and questions that wouldn't let go of him again. He holds an associate degree as Management Assistant in Publishing, a bachelor's degree in Sociology and a master's degree in Public Communication.

#### **Bernhard Krane**

Studied Theology and History at the Free University of Berlin, the Hebrew University of Jerusalem and the University of Paderborn. Many years of voluntary engagement within the German-Israeli relations. Lecturing and teaching activities for several German-Israeli organizations and programs. He is the desk officer of Action Reconciliation Service for Peace (ARSP), responsible for the countries Israel, Belgium and Great Britain. He is also in charge of supervising the ARSP volunteer program for German apprentices and the international summer camps of ARSP.

#### Renate Krekeler-Koch

Renate Krekeler-Koch works at Ludwig Wolker Haus in Berlin has a master's degree in European Studies and Intercultural Education. She has work experience as trainer, facilitator and project manager in the field of European educational and cultural programs such as Erasmus+ Youth in Action/ Leonardo

da Vinci, Europeans for Peace. Her thematic focus is intercultural and diversity education.

#### **Norbert Kron**

Norbert Kron, born 1965 in Munich, lives since 1992 in Berlin as a writer, journalist (ARD) and developer of art concepts. Norbert Kron founded the art project "Art Escort", an Agency for encounters with artists in Berlin. In 2015 he founded the book-project "We do not forget, we go dancing" – the publishing of an anthology of contemporary German and Israeli authors. His latest book "At home in a foreign place" focuses on the educational approach of the Bialik Rogozin School in Tel Aviv, offering "a home" for refugee and migrant children and youth.

# **Hellmut Königshaus**

Hellmut Königshaus is a lawyer and politician. Since 2015 he is the president of the "German-Israeli Society". #### Christine Mähler

Christine Mähler is the Director of ConAct — Coordination Center German-Israeli Youth Exchange, the German federal office guiding the national youth exchange program between Germany and Israel. Christine Mähler is a psychologist and mediator. She has done qualitative research on the impact of the Holocaust on members of the second generation of Jewish Holocaust Survivors in Germany and Israel. Before founding ConAct she was an educational coordinator at the NGO Action Reconciliation Service for Peace and at the memorial site of Sachsenhausen. Christine Mähler has been involved in German-Israeli encounters for thirty years. In addition, she appears in *Verräter – Die letzten Tage* (Traitor - The Last Days) by Falk Richter and in Ersan Mondtag's production of *Oedipus and Antigone*. She also has her own one-woman Oritsy-Show.
